Rules & Requirements:

1. All participants must have a valid photo I.D. to enter park.
2. Participants under the age of 18 must have a legal guardian complete and sign the liability and medical release form in the presence of a YMCA staff member.
3. All participants must wear elbow pads, kneepads, and helmet.
4. Spectators must use the bleacher area, and cannot be on the skate park surface.
5. NO SMOKING
6. Proper language and behavior is expected at all times, pants/shorts must be a waist level (underwear not shown).
7. No food or drink allowed inside the park.
8. Participants under the age of 10 must be supervised by a legal guardian.
9. No Skating, Biking, or boarding in the parking lot area or any area that is not the Skate Park.
10. Shirts must be worn at all times.
